Have been told that if you dial this number and don't push any buttons for the automated system, and let it go through the recording a couple times, you will then get a person.

PAYMENT INFORMATION

Until your employer withholds your child support payments from your pay check (of if you are self-employed or unemployed) you must make the payments yourself beginning on the date listed on the bottom of page one of your court order.

If you are paying by check or money order, make it payable to:

State Disbursement Unit and mail to P.O. Box 5400, Carol Stream, IL 60197-5400.

- 1) your name
- 2) the county in which the court order was entered
- 3) the court docket number of your specific case, for example (90D100) or (90F100)
- 4) the IV-D# of your specific case, for example (C123456)

IF YOU ARE PAYING FOR MORE THAN ONE DOCKET, TELL THEM HOW MUCH YOU ARE PAYING ON EACH DOCKET.

Other Payment Options arc:

<u>www.e-childspay.com</u> - You can make payments online using a credit card. You will have to register to use this service. For Illinois cases, a convenience fee is NOT charged. Visa, MasterCard and Discover are accepted. It can take up to 7 business days before your payment is posted to your child support account.

<u>www.expertpay.com</u> - You can set up automated payments (weekly, bi-weekly etc.) You will have to register to use this service and pay a one-time registration for of \$2.50. It can take up to 5 business days before your payment is posted to your child support account.

Pay by phone-1-866-645-6348 - There is a registration process for first time users. Once registered, you can make payments online using Visa, MasterCard or Discover. It can take up to 7 business days before your payment is posted to your child support account.

INSTRUCTIONS TO FILE A PETITION FOR MODIFICATION OF SUPPORT

- 1. Fill out the attached Petition COMPLETELY.
 - a. Enter the custodial parent's name as oblige, and the non-custodial parent's name as the obligor.
 - b. Enter the court docket number in the blank titled "Case No." This number can be obtained from your copies of the previous court order.
 - c. In the blank space in item #1, enter the date of the most recent support order in your case.
 - d. In item #2, state your reasons for requesting the change.
 BE SPECIFIC AND PROVIDE AS MANY DETAILS AS POSSIBLE.
 - e. Sign the petition where indicated, print your name, address, and phone number.
- 2. Take or mail the completed form to the Putnam County Circuit Clerk's Office at: 120 N. 4th Street, PO Box 207, Hennepin, Illinois 61327
- 3. If the oblige is NOT receiving IDPA SERVICES, you must obtain a hearing Date from the Clerk and send copies to all interested parties.
- 4. The Circuit Clerk's office will provide you a file-stamped copy of the petition. If oblige IS receiving IDPA SERVICES, the petition will be scheduled for hearing. The AAG's office will provide a Notice To Appear to both the custodial and non-custodial parents:
