**ORDINANCE PROVIDING FOR THE LEVY OF TAXES
FOR PUTNAM COUNTY, ILLINOIS
FOR THE FISCAL YEAR DECEMBER 1, 2021 THROUGH NOVEMBER 30, 2022**

WHEREAS, the annual appropriation ordinance of Putnam County, Illinois for the fiscal year December 1, 2021 through November 30, 2022, has been approved and adopted in accordance with Illinois law, and by reference, is made a part hereof.

NOW THEREFORE BE IT ORDAINED by the members of the County Board of Putnam County, Illinois, at its adjourned September session of said Board held in November A.D. 2021 that the sum of \$2,257,736 is to be raised from the tax levy for the fiscal year of said County of Putnam, State of Illinois, beginning December 01, 2021 and ending November 30, 2022, for all General Corporate purposes, for County Highway purposes, for County Bridge purposes, for Federal Aid Matching purposes, for Illinois Municipal Retirement purposes, for Social Security and Medicare Tax purposes, for Workers Compensation purposes, for Liability Insurance purposes, for Unemployment Insurance purposes, for County Health purposes, for Audit Levy purposes, for County Ambulance Service purposes, and for County Cooperative Extension Education Levy purposes, be and the same is hereby levied upon all taxable property in said County.

CORPORATE TAX LEVY

BE IT ORDAINED by the County Board in the County of Putnam, in the State of Illinois, that there be and there is hereby levied the sum of ONE MILLION FOUR HUNDRED AND NINE THOUSAND SEVEN HUNDRED 700/100 dollars-----(\$1,409,700) to cover and pay the expenditures for the fiscal year beginning December 01, 2021, and ending November 30, 2022, on all taxable property in the County of Putnam, State of Illinois, for the year 2022, and the County Clerk is hereby directed and authorized to extend the same at the rate of taxation on all the taxable property in said county and state that will produce said amount to be divided for the following purposes:

FEDERAL AID MATCHING TAX LEVY

AND BE IT FURTHER ORDAINED, pursuant to 605 ILCS 5/5-603, that there be, and there is hereby levied a FEDERAL AID MATCHING TAX in the sum of NINETY-SEVEN THOUSAND EIGHT HUNDRED and ELEVEN 11/100 dollars-----(\$97,811) for the purpose of providing funds to pay the proportionate share of said Putnam County expenses in construction of highways in said County in the Federal Aid Secondary network upon all the taxable property in said County, being in addition to the maximum of all other taxes which the County is authorized by law to levy, and the County Clerk is hereby authorized and directed to extend the same rate of taxation on all of the taxable property in said County that will produce said amount, said rate not to exceed .05% of the full, fair, cash value of all taxable property in said County of Putnam as equalized or assessed by the Department of Revenue.

COUNTY BRIDGE FUND TAX LEVY

AND BE IT FURTHER ORDAINED, pursuant to 605 ILCS 5/5-602, that there be and there is hereby levied a COUNTY BRIDGE FUND TAX in the sum of NINETY-SEVEN THOUSAND EIGHT HUNDRED and ELEVEN 11/100 dollars-----(\$97,811) for the purpose of paying one-half of the costs of construction of bridges in the respective towns for which the County Board has been petitioned for aid by the respective Commissioner of Highways of said township and such aid granted and the same appropriated from the County Treasurer therefore, being in addition to the maximum of all other taxes which the County is authorized by law to levy, and the County Clerk is hereby authorized and directed to extend said tax for that purpose at a rate not to exceed .05% of full, fair cash value of all taxable property in said County, as equalized or assessed by the Department of Revenue of the State of Illinois, said sum when so collected to be paid over to the County Treasurer and there deposited in the County Bridge Fund and used for no other purpose.

COUNTY HIGHWAY TAX LEVY

AND BE IT FURTHER ORDAINED, pursuant to 605 ILCS 5/5-601, that there be and there is hereby levied a COUNTY HIGHWAY TAX in the sum of ONE HUNDRED NINETY-FIVE THOUSAND SIX HUNDRED and TWENTY-ONE 21/100 dollars-----(\$195,621) for the purpose of improving, maintaining, repairing construction and reconstruction of County Highways required to be maintained, repaired and constructed by the County and acquiring and maintaining machinery for such purpose for the fiscal year beginning December 01, 2021, and ending November 30, 2022, on all taxable property in the County of Putnam in the State of Illinois for said year 2022, as a County Highway Tax upon all the taxable property in said County, said levy aforesaid being in addition to the maximum of all other taxes which the County of Putnam is authorized by law to levy on the aggregate valuation of all property within said County of Putnam, and the County Clerk is hereby authorized and directed to extend said tax for that purpose and at a rate not to exceed .10% of full, fair cash value of all taxable property in said County, as equalized or assessed by the Department of Revenue of the State of Illinois, said sum when so collected to be paid over to the County Treasurer and there deposited in the County Highway Fund and used for no other purpose.

COUNTY EMERGENCY AMBULANCE TAX LEVY

AND BE IT FURTHER ORDAINED, pursuant to 55 ILCS 5/5-1028, that there is hereby levied an EMERGENCY AMBULANCE SERVICE TAX of THREE HUNDRED SEVENTY THOUSAND FOUR HUNDRED and NINETY THREE 93/100 dollars-----(\$370,493) for the purpose of providing emergency ambulance service for the Granville-Hennepin Fire Protection District and Standard Fire Protection District in Putnam County, Illinois, and the County of Putnam be, and is hereby authorized by law to levy, and the County Clerk is hereby authorized and directed to extend the same rate of taxation on all the taxable property in said districts within said County

that will produce said amount, said rate not to exceed .25% of the full, fair, cash value of all taxable property in said districts within the County of Putnam as equalized or assessed by the Illinois Department of Revenue.

COUNTY HEALTH DEPARTMENT TAX LEVY

AND BE IT FURTHER ORDAINED, pursuant to 55 ILCS 5/5-23002, that there is hereby levied a COUNTY HEALTH DEPARTMENT TAX of TWENTY SEVEN THOUSAND THREE HUNDRED and no/100 dollars-----(\$27,300) for the purpose of providing a health department in combination with tuberculosis treatment services in Putnam County pursuant to an act in relation to the establishment and maintenance of county and multi-county health departments, and pursuant to Putnam County Board Resolution No. 85-23 and Public Act 82-0655; and the County of Putnam is hereby authorized by law to levy, and the County Clerk is hereby authorized and directed to extend the same rate of taxation on all the taxable property in said county that will produce said amount, said rate not to exceed .075% of the full, fair, cash value of all taxable property in said County of Putnam as equalized or assessed by the Illinois Department of Revenue.


COUNTY COOPERATIVE EXTENSION EDUCATION LEVY

AND BE IT FUTHER ORDAINED, pursuant to 505 ILCS 45/8, that there be and there is hereby levied an annual Cooperative-Extension Tax in the sum of FIFTY-NINE THOUSAND and no/100 dollars-----(\$59,000) for the purpose of providing county extension education funds in Putnam County pursuant to an act entitled the "County Cooperative Extension Law"; and the County of Putnam is hereby authorized by law to levy, and the County Clerk is hereby authorized and directed to extend the same rate of taxation on all the taxable property in said county that will


produce said amount, said rate not to exceed .05% of the full, fair, cash value of all taxable property in said County of Putnam as equalized or assessed by the Illinois Department of Revenue.
