## INTERGOVERNMENTAL AGREEMENT BETWEEN PUTNAM COUNTY AND PUTNAM COUNTY CONSERVATION DISTRICT

This Intergovernmental Agreement (referred to as the "Agreement") is entered into this 13th day of February, 2024 between Putnam County, located at 6203 IL Highway 26. Hennepin, IL 61327, in the County of Putnam and State of Illinois (referred to as Putnam County) and the Putnam County Conservation District, located at 4526 E 1000th St, Hennepin, IL 61327, in the County of Putnam and State of Illinois (referred to as the Conservation District).

WHEREAS, the 1970 Illinois Constitution, Article VII, Section 10, and the Illinois Compiled Statutes, as amended, Ch. 5 Section 220/1 et seq. provide legal authority for intergovernmental privileges and authority to be enjoyed jointly by counties, municipalities as well as other public bodies politic; and

WHEREAS, the Conservation District is in need of certain road repairs; and

WHEREAS, the Conservation District has requested the assistance of the Putnam County Engineer to arrange for such work.

## WITNESSETH

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto agree as follows:

- 1. PUTNAM COUNTY agrees to prepare the necessary paperwork for the 2024 road work for the Conservation District.
- 2. PUTNAM COUNTY will prepare the required paperwork to bid the road work in conjunction with the County and Township work for 2024.
- 3. PUTNAM COUNTY will provide on-site inspection as work is being done.
- 4. PUTNAM COUNTY will review and confirm the quantities billed prior to payment to the Contractor from the Conservation District's funds.
- 5. The Conservation District agrees to pay PUTNAM COUNTY the following as established by Putnam County Resolution #2624-05 dated February 13, 2024.
  - \$1,250 administrative fee;
  - + Three (3) percent of the total maintenance operation amount for preliminary engineering;
  - + Three (3) percent of the total maintenance operation amount for on-site inspection.
- 6. This agreement shall be binding upon and inure to the benefits of the parties hereto, Their successors and assigns.
